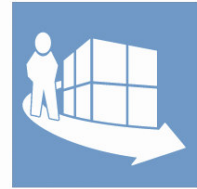

## **Vision Zero in the Waste Industry**

23-24 OCTOBER 2019, HAMBURG

At its third international symposium, which will take place from 23-24 October 2019 in Hamburg, the International Section of the ISSA on Prevention in Transportation will shed light on the topic of occupational health and safety in the waste industry.

Company representatives, occupational safety specialists, municipal contracting authorities, scientists, labor inspectors and social security experts from a number of countries will discuss issues such as:

- How can the health and safety goals in the waste industry be achieved even better and faster with the Vision Zero strategy?
- What solutions for the improvement of occupational health and safety are already being implemented in cities in other countries?
- How have technological developments and modern logistical collection concepts affected occupational health and safety to date?
- What does demographic change, qualification and internationalization of the working world mean for companies operating in the field of waste management?
- What role do the “seven golden rules of Vision Zero” play in the successful implementation of occupational health and safety goals?

The global prevention initiative “Vision Zero” aims to reduce fatal and severe accidents to zero and promote a culture of safety, health and well-being at work. The implementation of Vision Zero should be an integral part of comprehensive company quality management. In this context, it is important that the resources used for occupational health and safety are not seen as costs, but rather as investments. These resources also provide a significant return on investment. The International Section of the ISSA on Prevention in Transportation will use good practical examples from the fields of waste collection and waste processing to explore with the symposium participants how the Vision Zero strategy can be used not only to improve occupational health and safety, but also to make a contribution to the achievement of broader company goals.

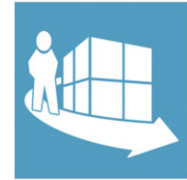

#### B1) Bio-agents in the waste industry – still a problem?

##### Dialogue between science and industry for optimal health protection

Biochemicals in waste management can cause irritation, allergies, infections and chronic bronchitis/COPD. In this workshop, the hazard potential will be presented and the effectiveness of possible protective measures will be discussed. In a dialogue between science and industry experts, we want to link scientific findings with practical prevention measures and at the same time identify the need for further research.

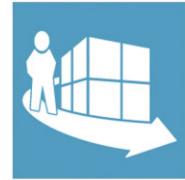

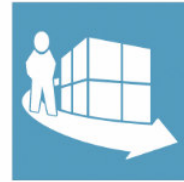

## **Processing your data - Privacy Policy**

The European General Data Protection Regulation is directly applicable as of 25/05/2018. We hereby inform you about how your data is protected during processing (information requirements pursuant to Art. 13, 14 of the GDPR).

### **1. Who is the controller of the data processing and who can you contact?**

### **2. What is the purpose of the processing?**

The purpose of the "Internationale Sektion für Prävention im Transportwesen e.V." is to promote prevention, in particular the prevention of industrial accidents and occupational illness in transportation, through international collaboration. For this purpose, it promotes knowledge transfer and stimulates the cooperation between experts by means of online- and offline media and the organization of international information events.

Personal data is processed for the purpose of member administration and collection of membership fees, as well as the organization, registration, participation management and communication as part of the aforementioned events.

### **3. What is the legal basis for the collection and processing of your personal data?**

#### 1. Legal regulations

Your data is subject to the provisions of the European General Data Protection Regulation (GDPR) and the German Federal Data Protection Act. This means that "Internationale Sektion für Prävention im Transportwesen e.V." will process your data only to the extent required by law and laid down in its Articles of Association, while your data will only be accessible to those employees who require it to perform their tasks.

#### 2. Consent

In addition to data processing due to legal obligations/powers, data may also be processed if you give your consent to such processing taking place (Art. 6 I a and Art. 9 II a of the GDPR).

### **4. What categories of personal data may be processed?**

The following is considered to be relevant personal data:

Personal information (surname, first name, date of birth, place of birth, gender, nationality, passport details, etc.), contact details (business contact: employer, position, address, telephone number, email address, etc.), processing data (e.g., account details)

### **5. Who has access to your data?**

Your personal data will not be shared with any institutions other than "Internationale Sektion für Prävention im Transportwesen e.V.", unless we have relevant legal powers to transfer your data or you give us your consent for doing so.

Possible categories of recipients:

Service providers: e.g., conference and event venues, conference hotels, institutions, businesses whose factories are visited (list of participants)

**6. Is your data transmitted to a third country or an international organization?**

As a rule, your data will not be transmitted to a country outside the European Union or a country without an adequate level of data protection or to an international organization, though this may happen in individual cases, e.g. when events are organized in such countries.

**7. How long is your data stored?**

The data is stored for as long as it is necessary for the task to be fulfilled and required for compliance with retention obligations arising from the law or the Articles of Association.

The storage period depends on various factors:

Invoice data as well as any relevant evidence must be stored for a period of 6 or 10 years.

**8. What are your data protection rights?**

You have the right to information about the processing of your personal data and the right to access your data at any time. Providing that certain legal requirements are fulfilled, you also have the right to rectification, erasure and restriction of processing.

**9. Your right to withdraw consent**

If your data is processed on the basis of your consent, you obviously have the right to withdraw your consent at any time. However, please note that your withdrawal of consent does not have a retroactive effect, which means that the processing carried out by the time you withdraw your consent will remain legally valid.

You can submit your withdrawal of consent to the body responsible. The contact details can be found in section 1.

**10. Your right to complain**

If you believe that your rights have been violated during the processing of your personal data, you may also contact the Data Protection Supervisory Authority. The Data Protection Supervisory Authority responsible for us is:
