



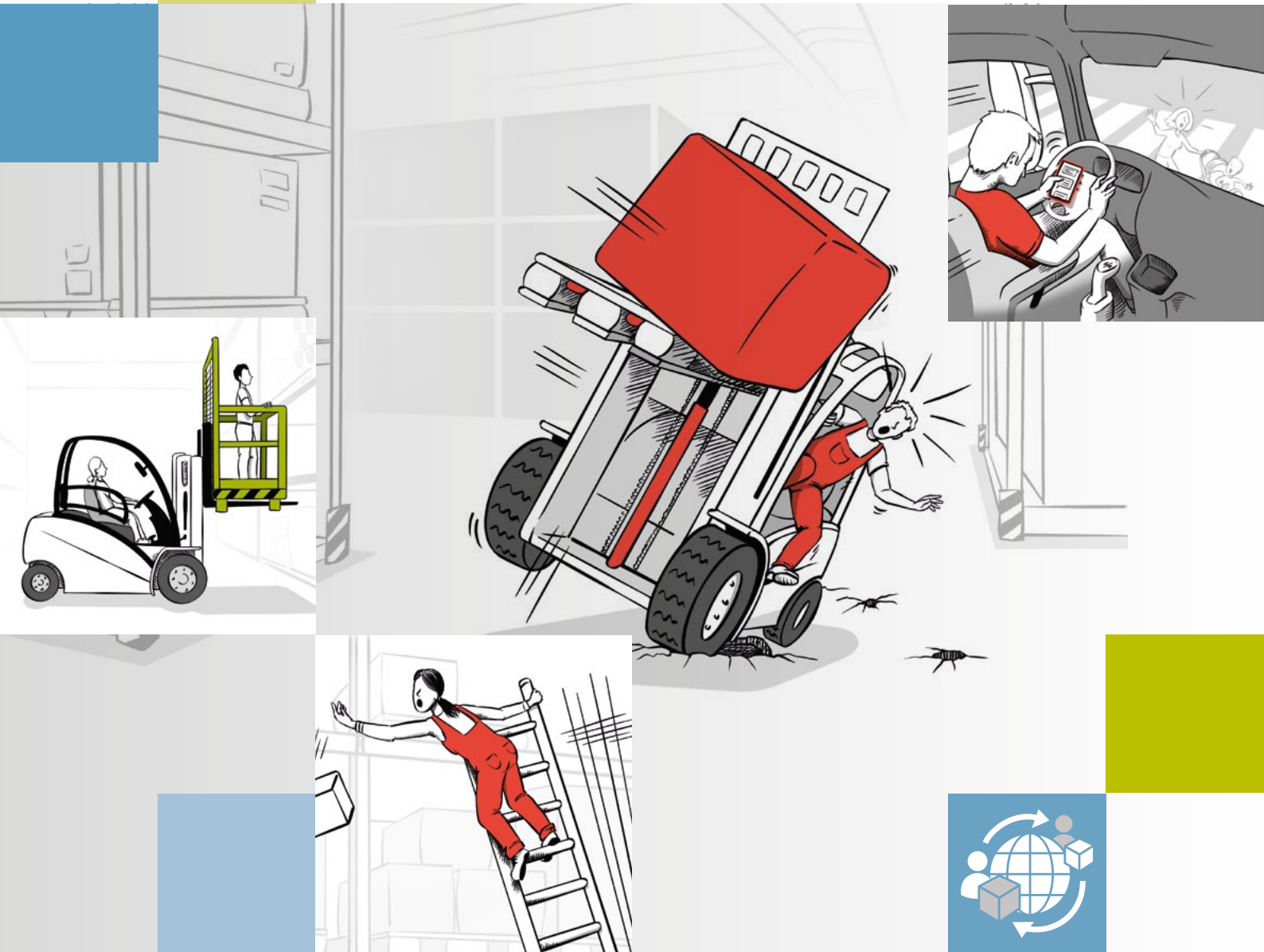

Fatal Accidents in Trade and Logistics Industries

The German Statutory Social Accident Insurance Institution for the Trade and Logistics Industries (BGHW) systematically evaluated the fatal work accidents in the period from 2012 to mid-2019 in Germany. Essentially, the 315 fatal work accidents that occurred in this period can be divided into six focal points.

The combined data led to additional findings on fatal work accidents. The results of these evaluations are summarised in sketches. The aim of this collection of sketches is to share the knowledge about fatal

accidents in trade and goods logistics for information, sensitization and instruction of employees as well as for the (further) development of operational measures to prevent such accidents at work.

This publication is a contribution to an international exchange of knowledge and to the global VISION ZERO strategy.

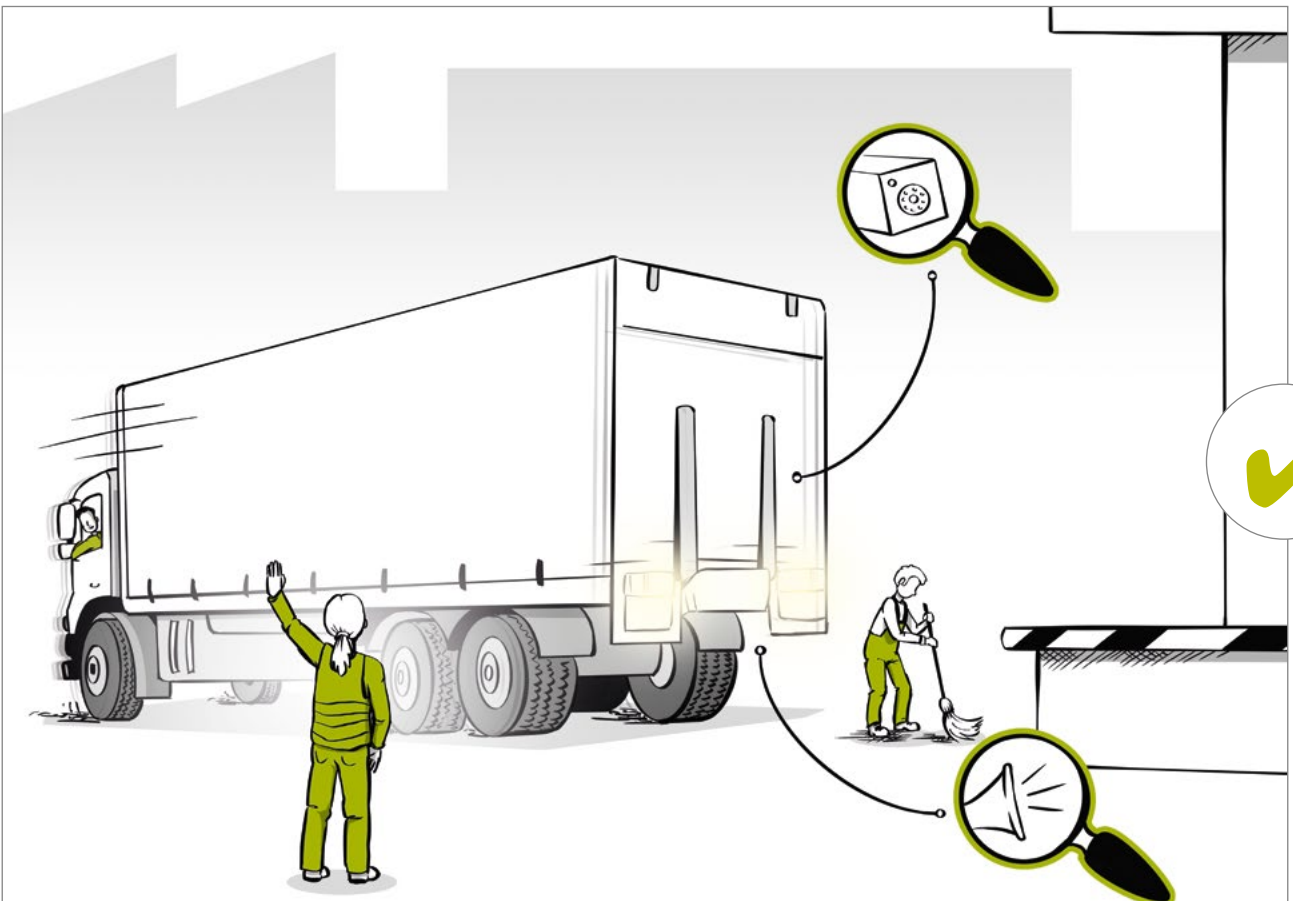
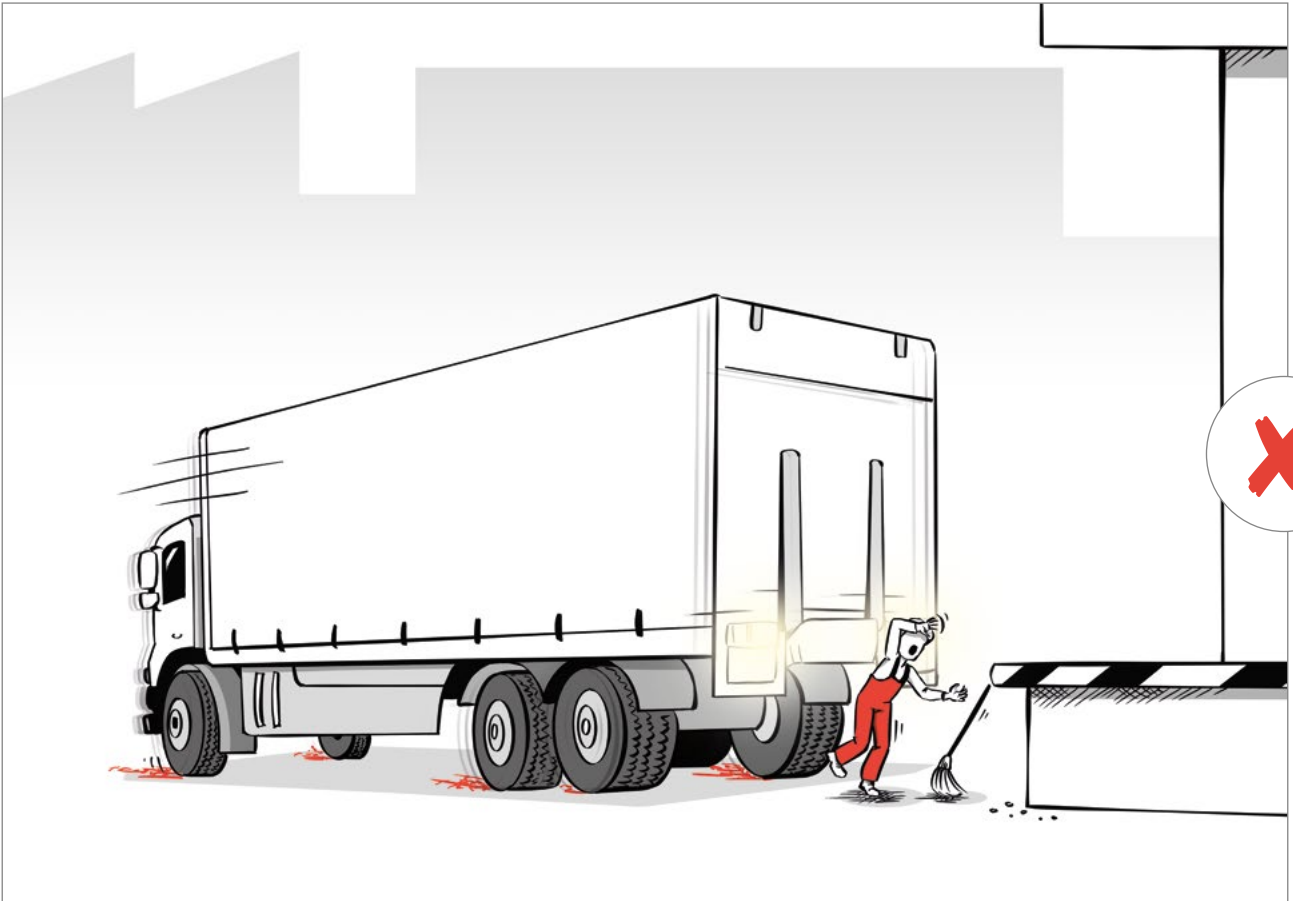


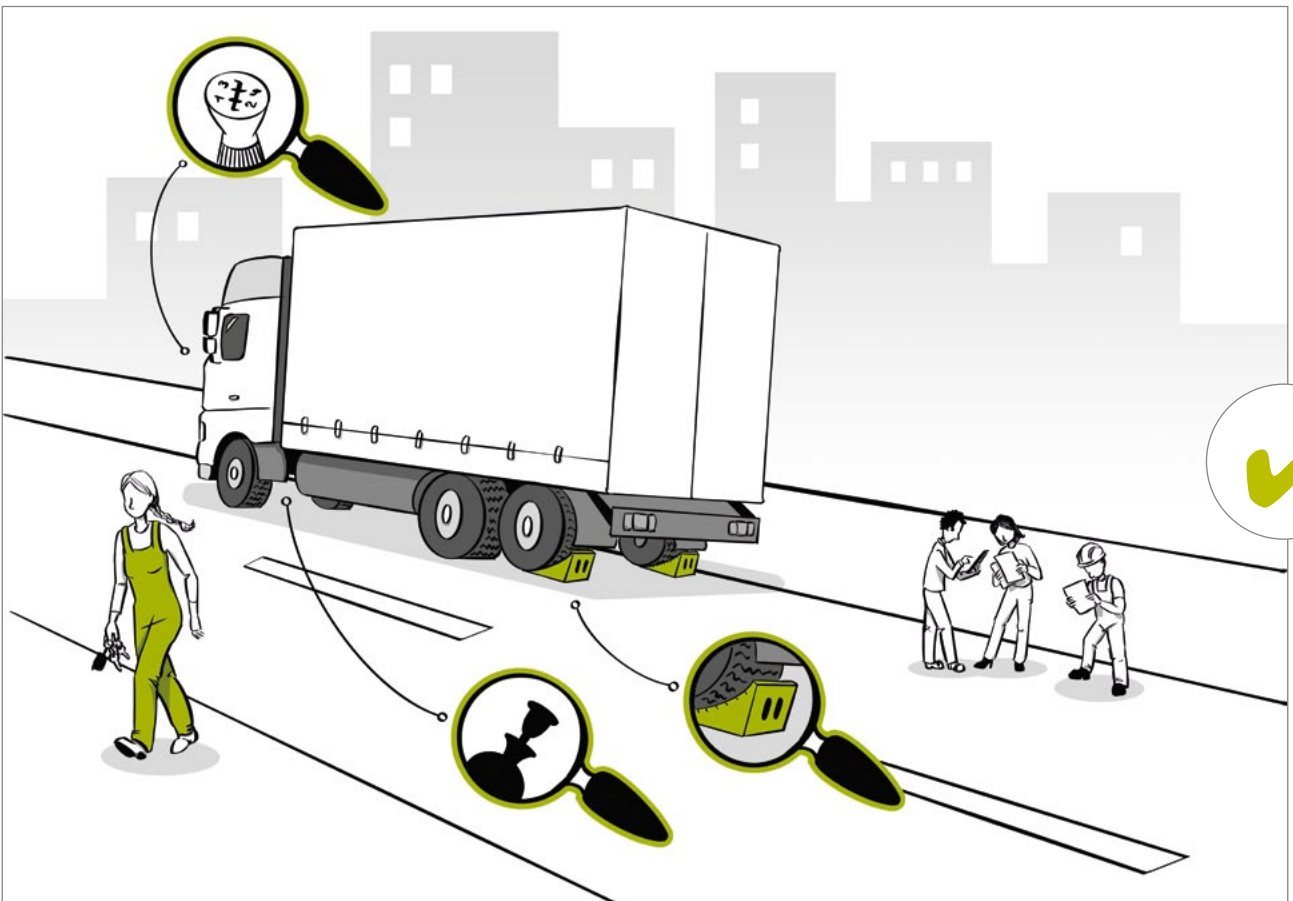
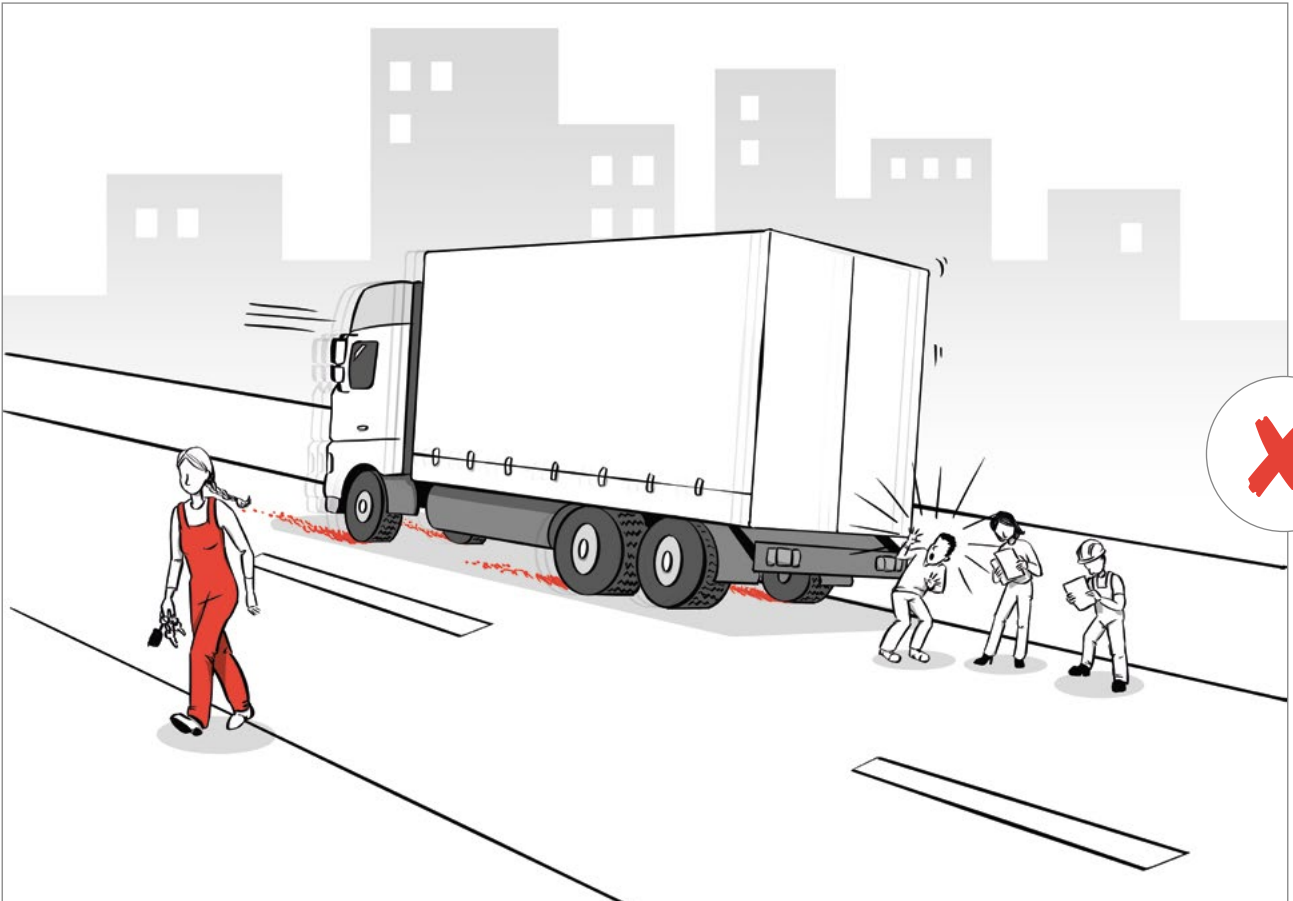


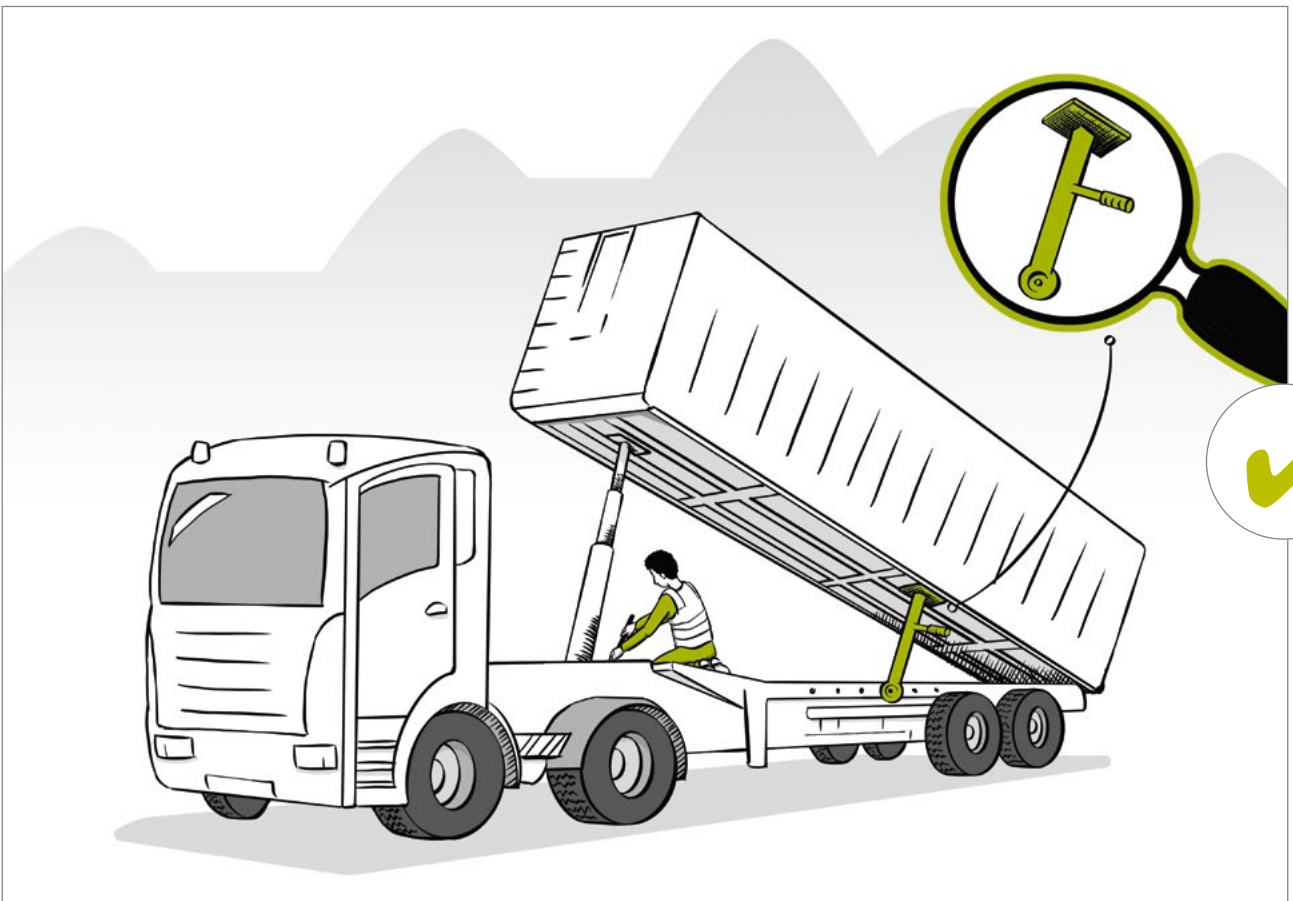
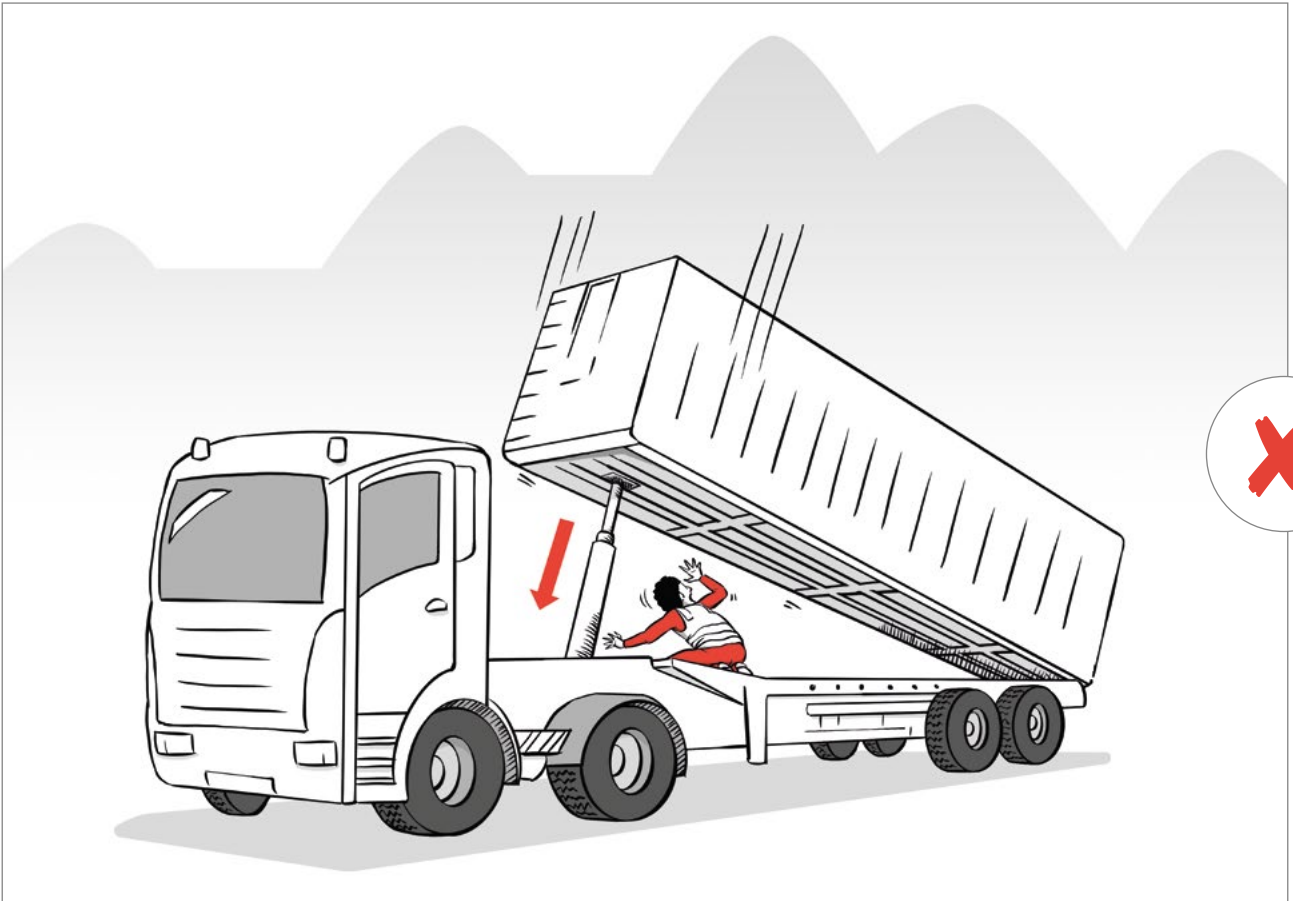


3. Accidents caused by being caught, rolled over or crushed by vehicles and construction machinery



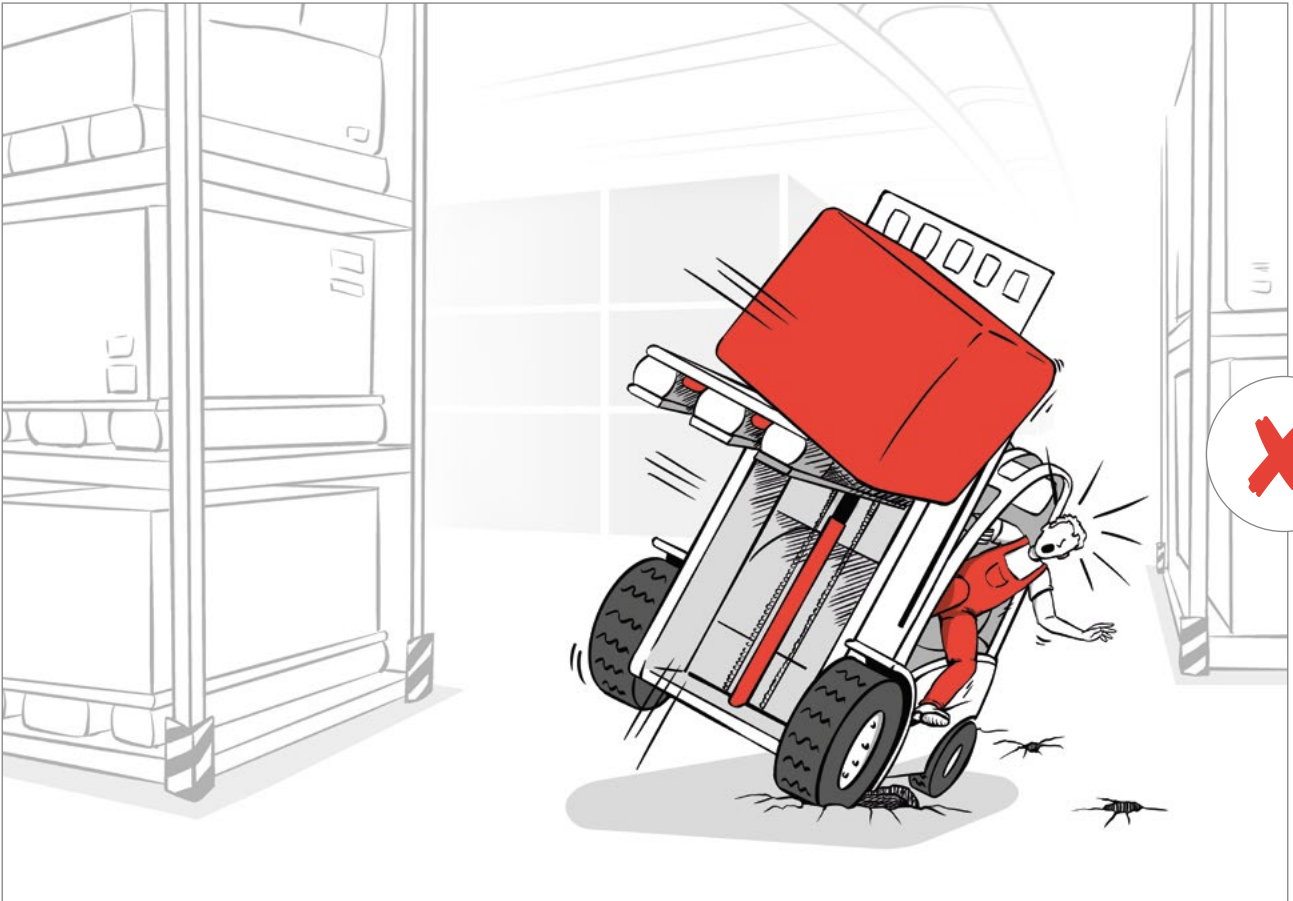


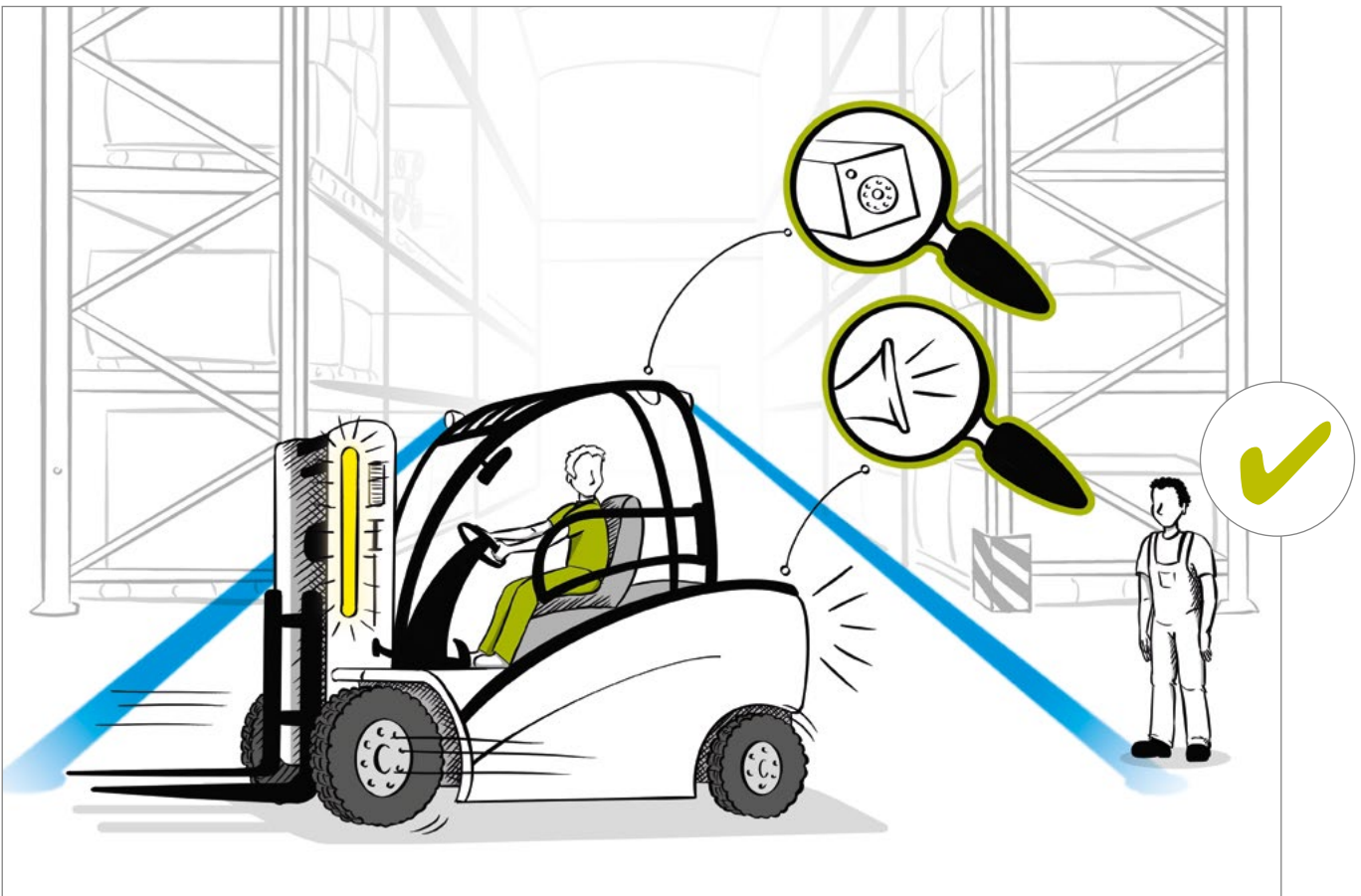




4. Accidents involving industrial trucks



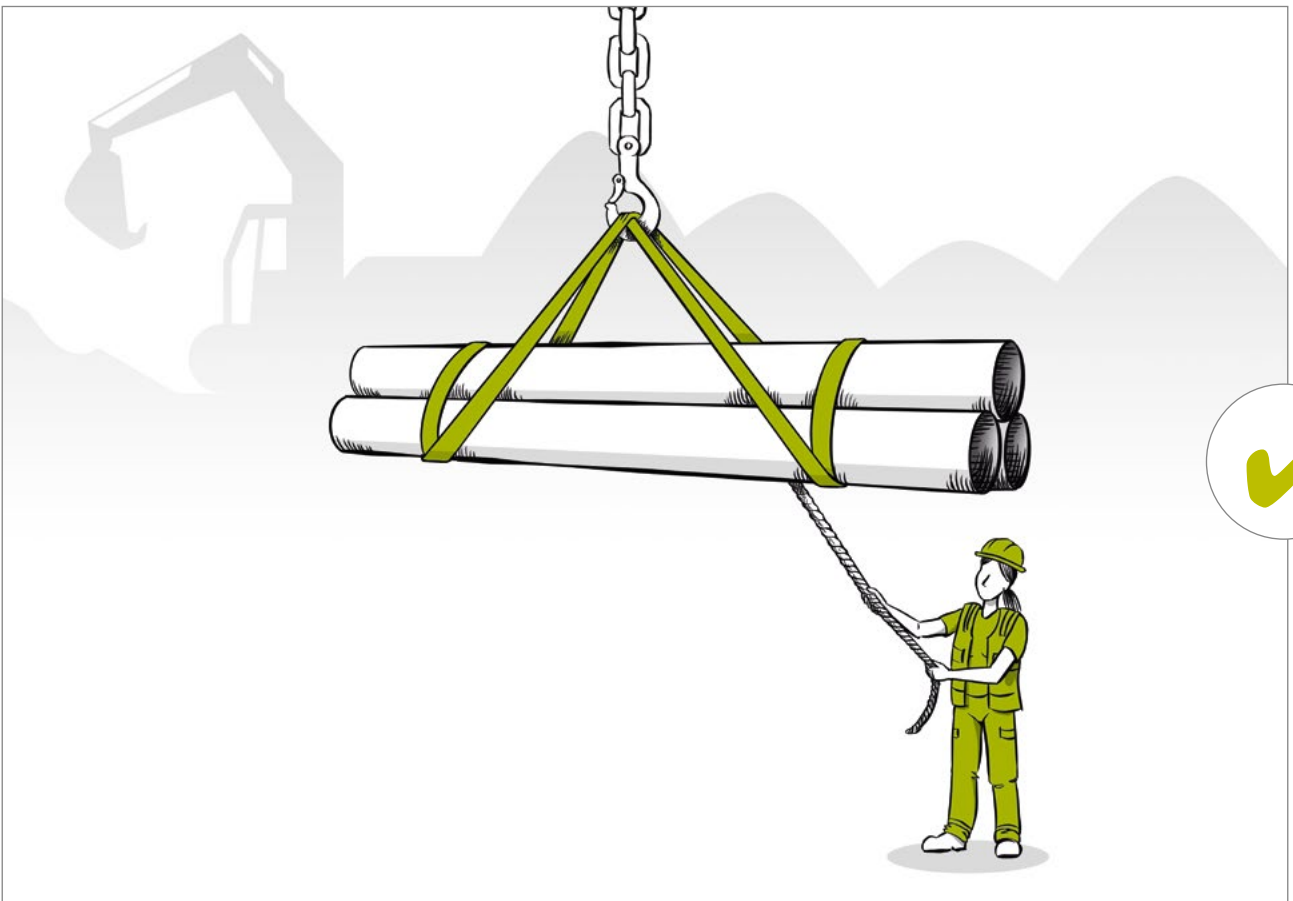


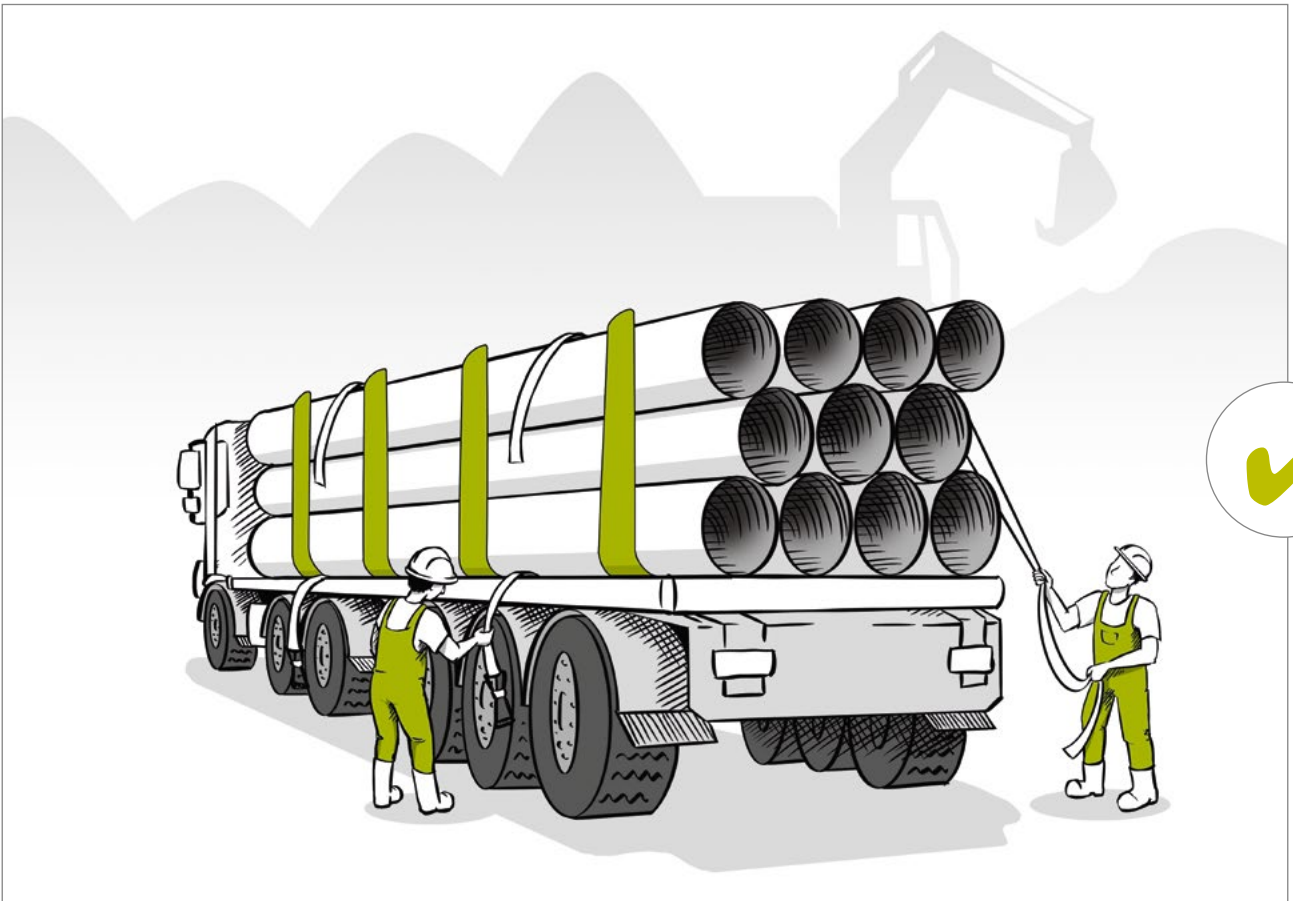
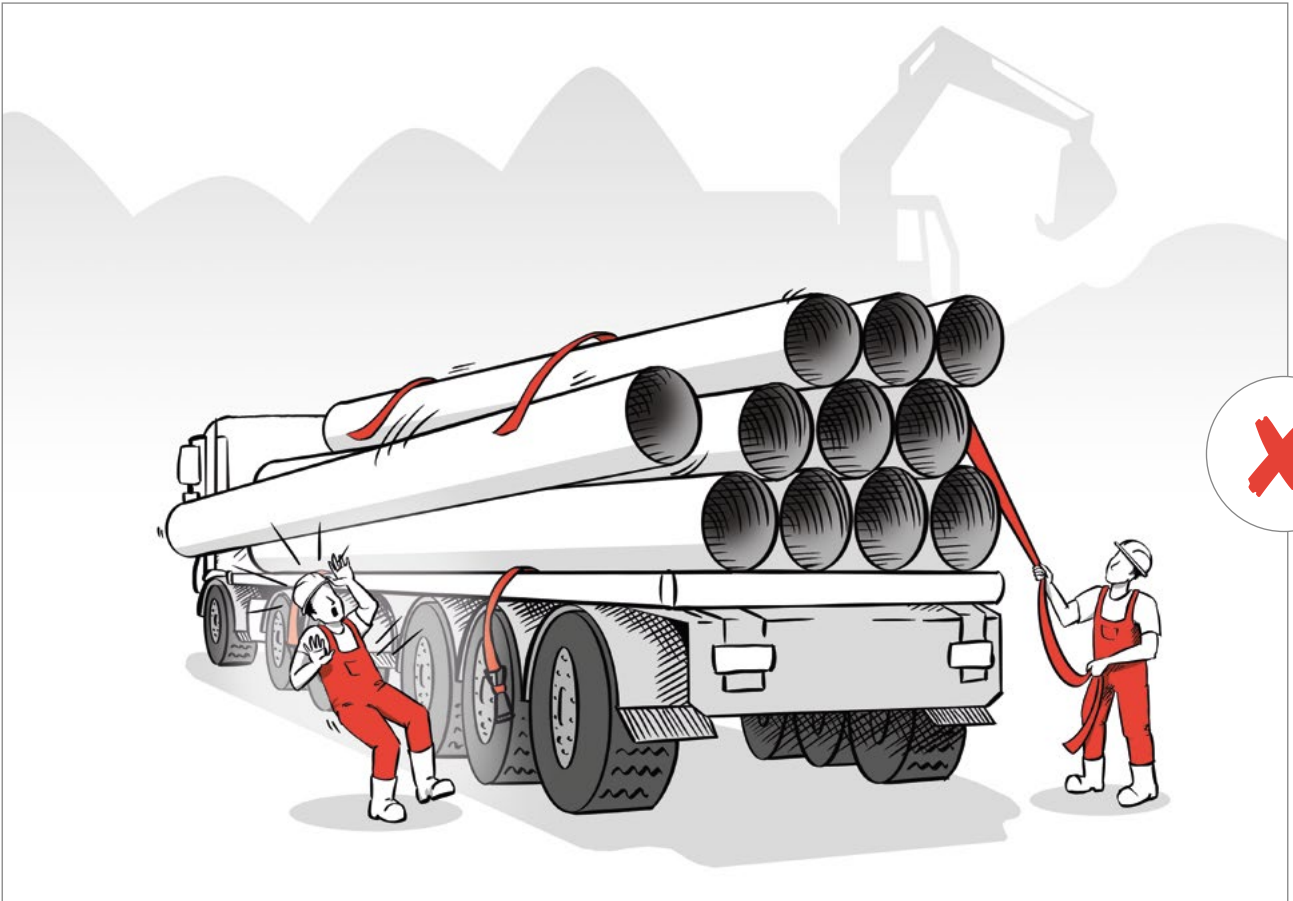


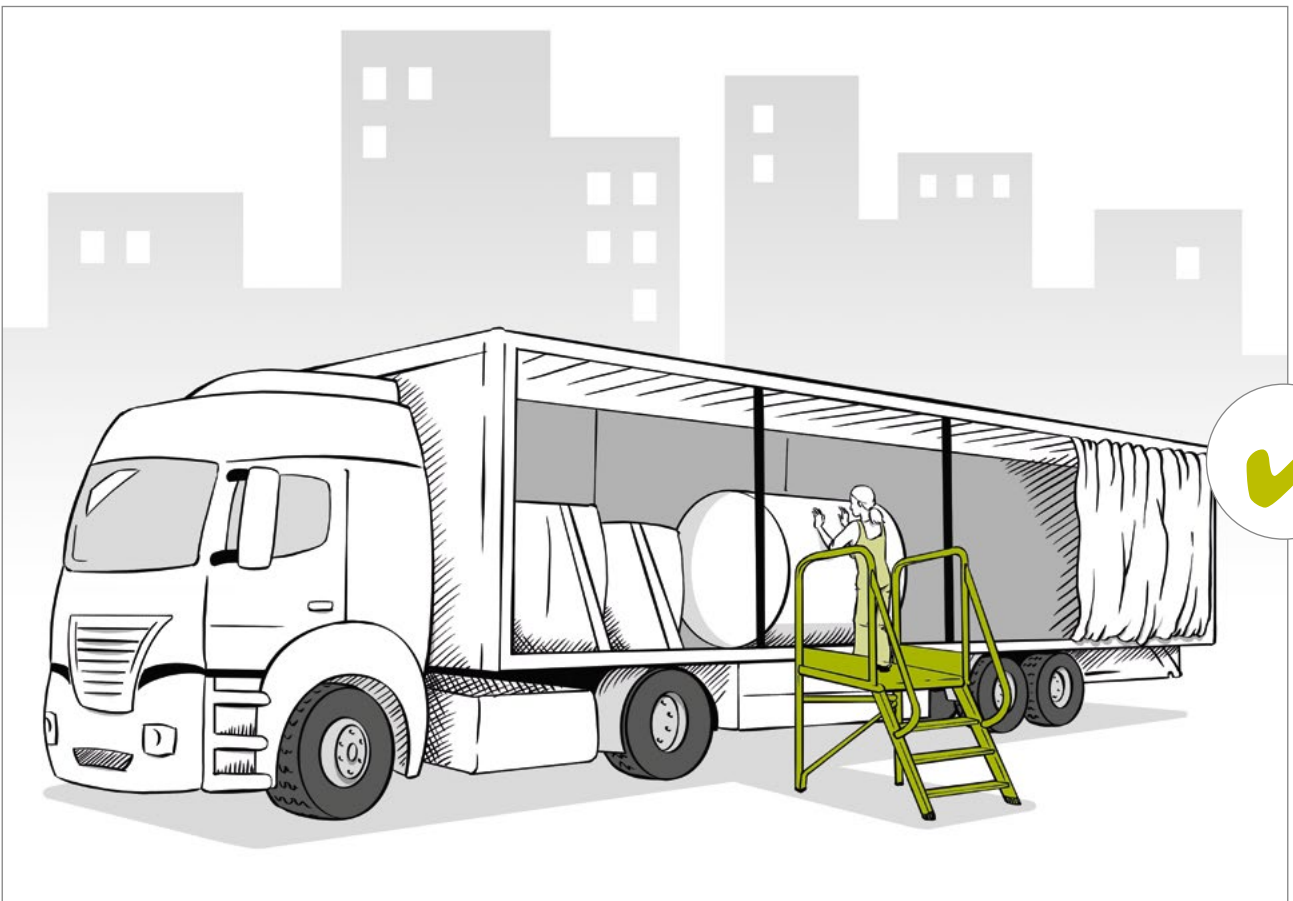


5. Accidents during the loading and unloading of vehicles
