

The International Labour Organization (ILO) is honoured to join SafeWork NSW and the International Social Security Association (ISSA) as co-organisers of this global event under the theme "Shaping Change: Collaborating for a healthier and safer world of work". The Congress will discuss how the world of work is changing and why anticipating new and emerging health and safety risks is more important than ever.

As the world recovers from the COVID-19 pandemic, drivers of change such as demography, climate, technology, and globalisation have an increasing impact on working conditions and on the nature of occupational hazards.

Ensuring safety and health at work has been at the core of the ILO's mandate since its foundation. The ILO's Constitution recognises the protection of workers against sickness, disease and injury arising out of employment as a crucial element of social justice. The 1944 Philadelphia Declaration also recognises the solemn obligation of the ILO to further "adequate protection for the life and health of workers in all occupations".

More recently, at its 110th Session in June 2022, the International Labour Conference took the landmark decision of amending the ILO Declaration on Fundamental Principles and Rights at Work (1998) to include "a safe and healthy working environment" as a new fundamental right, and to designate the Occupational Safety and Health Convention, 1981 (No. 155) and the Promotional Framework for Occupational Safety and Health Convention, 2006 (No. 187) as fundamental Conventions. For its part, the ILO is stepping up its work on occupational safety and health to support its members to respect, promote and realise the universal right to a safe and healthy working environment through combined efforts to prevent death, injuries, and ill-health due to work.

The World Congress will serve as an excellent opportunity to share and exchange knowledge and experience, as well as chart a course to tackle existing and newly emerging issues regarding the safety, health, and wellbeing of all.

This year, we will come together in Sydney to debate and find the optimal solutions to make the world of work safer and healthier.

Together with the social partners and the ministries in charge of occupational safety and health, they actively promote a global prevention culture with the goal of zero occupational accidents and diseases.

The ISSA promotes the values of prevention through its powerful set of tools, such as the Guidelines on occupational risk prevention, workplace health promotion and return to work.

The ISSA's Vision Zero strategy offers easy-to-implement solutions for companies and policy makers. In fact, there are companies that have managed to reduce their Lost Time Injury Frequency Rate by adopting the ISSA's Vision Zero proactive leading indicators. Also, there are social security institutions who have had great outreach success by aligning their prevention strategy to the Seven Golden Rules of Vision Zero.

For the first time in its history, the World Congress will be held in Australia, and I would like to take this opportunity to thank our host, the Australian Government and SafeWork NSW, for showcasing the value and benefits of prevention. Prevention must always come first, and we embrace this fact now that there are new technologies to improve occupational safety and health in a connected, digital world of work.

Blurred Lines: Challenging the Boundaries of OSH

The boundaries between life and work are becoming increasingly blurred, where personal well-being, values, and aspirations converge with professional responsibilities and career ambitions.

For many workers the COVID-19 pandemic resulted in an increased integration between work and life, with a 2022 Conference Board survey of 1,300 predominantly professional and office workers indicating 58% of those surveyed saw an increased integration between work and life, and 47% concerned about blurred boundaries e.g., difficulty unplugging from work. Blurred Lines: Challenging the boundaries of OSH will examine how traditional boundaries are shifting across a range of industries, and discuss emerging issues and ways of supporting workers, business, and policy makers.

Harm Prevention in the Mining Sector

Did you know mining is one of the world's most hazardous jobs? This symposium explores how can we reduce the number of work-related injuries, disease, and death in this complex and diverse sector.

Although only accounting for one percent of the global workforce, the International Labour Organisation states mining is responsible for about eight percent of fatal accidents at work. No reliable data exists on injuries, but they are significant. In some countries, many more people are employed in small-scale, often informal, mining than in the formal mining sector. Many of these jobs are precarious and are far from conforming with international and national labour standards. Accident rates in small-scale mines are routinely six or seven times higher than in larger operations, even in industrialised countries.

Founded in 1919, the ILO became the first United Nations specialised agency in 1946 with 187 Member States. Additionally, the ISSA promotes investments in workers' health by providing good practice information, research, expert advice and a network for members and other stakeholders to exchange on innovation in workplace health promotion, active employment policies, rehabilitation and reintegration. To implement a range of projects and activities, the ISSA Secretariat works closely with its Technical Commissions, the Special Commission on Prevention, and its unique network of International Prevention Sections.


As well as being a regulator, SafeWork NSW commits to reducing workplace hazards and risks and preventing workplace accidents. It supports businesses by:
