# THE YEAR IN REVIEW

As the ISSA celebrates its 90th anniversary, it continues to represent and build the only global community of social security administrators. The exceptional group of leaders and professionals who make up the membership of the Association have helped the ISSA become a highly relevant and crucial partner to social security administrations around the world. The past year marks another milestone - seeing the completion of the first phase of the Centre for Excellence, as well as the extension of the ISSA's influence into groups such as the G20, BRICS and **OECD.** The ISSA is looking to the future with exciting plans for the development of innovative responses to the key challenges faced by social security.

The ISSA has travelled far since 1927 when 17 sickness insurance and mutual benefit societies came together at the initiative of the International Labour Organization. Ninety years later, the ISSA represents over 320 member organizations who collectively cover over 3 billion people, manage over 6 trillion dollars of funds and employ over 3 million people. For the first time in its history, the ISSA membership spans 158 countries.

A highlight of the year was the World Social Security Forum (WSSF), in Panama in November 2016. The event was an important moment for social security, welcoming over 1,000 professionals from around the world to analyse the major trends and challenges affecting social security. The ISSA launched a ground-breaking new report: 10 Global Challenges for Social Security, which summarized the key global issues facing social security administrations. The event also saw the presentation by the ISSA of plans to monitor, collate and assess practical innovative responses to meet the challenges ahead.

The ISSA is unique in offering professional leadership on matters of social security administration. This was clearly demonstrated at the WSSF, with the launch of four new Guidelines and with fresh and revised material added to existing Guidelines. The Centre for Excellence now offers 12 comprehensive sets of ISSA Guidelines on key areas of social security administration, all available in various languages. These are accessible through our redesigned website and new App, supported by tailored publications and good practices.

Another important stage in the roll-out of the Centre for Excellence was the first completion of the ISSA Recognition programme by two member institutions who received the "Certificate of Excellence" in Panama for their application of ISSA Guidelines. The successful launch of the Recognition programme completes the first phase of the Centre for Excellence that was initiated in 2014.

The WSSF also saw the election of a new President and Treasurer, along with members of the Bureau, and the Chairperson and members of the Control Commission.

The ISSA continues to build its international presence and influence, being invited to important international events such as the G20 and the BRICS Labour and Employment Ministers' Meeting. Its network expanded through the opening of a new ISSA Liaison Office for Pacific Island Countries in Suva, Fiji, as well the transfer of the ISSA Liaison Office for Central Africa from Cameroon to Gabon.

With the approval of 2017–2019 programme and budget, there are exciting plans for the development of the Association to meet the rapidly evolving needs of its members.

These aim to build an even closer engagement with our members, and to develop responses for our global membership in view of key social security challenges and the profound transformations brought about by the digital economy. The launch of an ISSA innovation programme to identify and share innovative solutions and approaches will not only enrich the value of ISSA's Centre for Excellence but enable the ISSA community to better shape the future of social security.

We would like to express our gratitude to all our members, partners and staff who have actively contributed to a highly productive year. We would particularly like to thank the outgoing officers: the President Mr Errol Frank Stoové, the Vice-President Mr Said Ahmidouch and Treasurer Mr Philippe Conus for their strong leadership and support over the past triennium. We look forward to another active and engaging period for our vibrant Association over the coming years.

#### WORLD SOCIAL SECURITY FORUM

The World Social Security Forum is the largest international event for social security decision makers and professionals. Organized by the ISSA, it was hosted by the Social Insurance Fund of Panama in Panama City from 14 to 18 November 2016.

#### > Social security is an investment

Social security has a major and long-term positive impact on people, societies and economies, and is an essential investment in human capital and social cohesion.

#### Universal coverage for all by 2030 is a global goal

More people are protected today by social security than ever before, and there is a strong political commitment, enshrined in the UN Sustainable Development Goals, to achieve social protection for all by 2030.

#### Social security is faced with a series of complex global challenges

A new report, 10 Global Challenges for Social Security, launched by the ISSA during the Forum illustrates how social security systems are confronted with a series of complex global challenges. These are shifting the fundamental parameters on which social security systems are founded, and will require strategic and coordinated responses by social security institutions, as well as innovation in administration.

#### Innovation is essential for the future of social security

The challenges confronting social security require policy-makers and administrators to identify innovative responses to ensure sustainability and meet evolving risks and demands.

#### Social security must ensure people-centred approaches and strive for excellence

In response to increased public expectations, social security institutions aim for excellence in administration based on technological innovation and a strengthened focus on person-centred service delivery.

#### The ISSA provides a global platform for social security administrations

The ISSA is the unique global community for social security administrators to exchange on strategies to develop and identify innovative solutions to the challenges facing social security.

#### **Election of new ISSA officers**

The ISSA Council elected a new President and Treasurer for the Association, respectively Dr Joachim Breuer, Director-General of the German Social Accident Insurance, and Mr Nicolay Kozlov, Deputy Chairman of the Board of the Pension Fund of the Russian Federation. The titular auditors and the deputy auditor of the Control Commission were also elected on this occasion (Mr Jean-Marc Vandenbergh, Belgium, Chairperson; Mr Pawel Jaroszek, Poland; Ms Patricia Koizan, Côte d'Ivoire; and Mr Raoul Romain Arizaka Rabekoto, Madagascar).

#### The ISSA Award for Outstanding Achievement in Social Security

The Government of the People's Republic of China was presented with the prestigious ISSA Award for Outstanding Achievement in Social Security in recognition of its unprecedented extension of pensions, health insurance and other forms of social protection.

#### **World Social Security Summit**

The Forum culminated with the World Social Security Summit, involving ministers and high-level officials from Argentina, Burkina Faso, China, Nigeria, the Russian Federation and Uruguay, as well as representatives of the ILO, OECD, United Nations and World Bank.

# 10 GLOBAL CHALLENGES

Global levels of social security protection are at an all-time high, and coverage continues to increase. Based on strong political commitment and excellence in administration, social security is transforming lives and shaping societies in all regions of the world.

The global community is committed to sustaining and further extending social security protection in line with the objectives of the United Nations Sustainable Development Goals for 2030. In order to reach this ambitious objective we need to better understand the challenges that we face and develop appropriate responses.

This is the reason why the ISSA has prepared a report that spotlights ten of the most important global challenges that confront social security systems.

#### > 10 global challenges report

The ISSA launched a ground breaking 2016 report 10 Global Challenges for Social Security at the World Social Security Forum in Panama City. The report's findings, which highlight the ten major challenges confronting social security administrations, are based on research and the consultation of more than 280 government departments and social security institutions around the world.

As well as facilitating a better understanding of the rapidly changing context for social security, the report provides interesting examples of how ISSA member institutions have used innovative solutions to successfully adapt to the identified challenges.

Building on the report, the ISSA is engaging with its members in each region to rank these global challenges in order of regional priority. The resulting reports will be launched at each of the Regional Social Security Forums over the coming three years.

#### INNOVATION

### Innovation is a key element of the ISSA Programme of activities 2017–2019.

The Innovation programme has been developed as a complementary dynamic dimension to the highly appreciated ISSA Centre for Excellence:

- > Moving beyond evaluated principles in Guidelines and good practices
- > Sharing innovative solutions to priority challenges
- > Developing innovations together for completely new issues

The Innovation programme was launched officially at the Bureau Symposium in June in the presence of distinguished guests, including official delegations from the United Nations in Geneva and the International Labour Organization, former elected officials of the ISSA, and representatives of ISSA member organizations and of regional social security organizations. The Symposium also marked the beginning of 2017 events to celebrate the ISSA's 90th anniversary.

The innovation programme will comprise two interconnected work streams. The first concerns innovative solutions to meet the 10 global challenges for social security. The second will address the impacts, risks and opportunities of the digital economy. These two agendas will be mainstreamed across ISSA's activities: the Technical Commissions, Regional structures and General Secretariat projects.

The main outputs of the programme will include, innovation networks and exchange at Regional Social Security Forums, professional conferences and regional technical seminars. There will also be the promotion of innovation through the ISSA innovation award, and a Leadership for innovation series with a focus on the role of CEOs. Finally there will be plans for working together to innovate through the ISSA innovation lab.

#### **DIGITAL ECONOMY**

The digital economy will profoundly transform our daily life, how we work and how we live.

To understand and develop responses to this transformation, the ISSA launched the Digital Economy and Social Security Observatory.

Grouping a multitude of topics linked to the digital economy and its impact on social security, and mainstreamed across all ISSA activities, the Observatory will provide ISSA member organizations with guidance on the opportunities and challenges presented to social security administrations.

The Observatory will look at this transformation from two perspectives:

- > How the digital economy may change the environment for social security
- > How the digital economy may impact social security administrations

In this endeavour, new tools provided to ISSA member organizations will include an expanding real-time Media wall offering video analysis and data.

This "look into the future" is supported by the ISSA technical commissions, findings from ISSA conferences and events, member surveys, good practices, literature reviews, research and input by external experts.


